(A) 第一按揭貸款 First Mortgage Loan

選擇付款計劃(A2)(即「60天現金連第一按揭付款計劃」)或付款計劃(B2)(即「240天現金連第一按揭付款計劃」)之買方可向賣方指定財務機構(「指定財務機構」)申請第一按揭貸款，主要條款如下：

The Purchaser who selects Payment Plan (A2)(i.e. “60-Day Cash Payment Plan with First Mortgage”) or Payment Plan (B2)(i.e. “240-Day Cash Payment Plan with First Mortgage”) can apply to the Vendor’s designated financing company ("Designated Financing Company") for a first mortgage loan. Key terms are as follows:

The First Mortgage Loan shall be secured by a first legal mortgage over the residential property.

The proposed interest rate of the First Mortgage Loan for the first 24 months shall be Hong Kong Dollar Best Lending Rate from time to time quoted by The Hongkong and Shanghai Banking Corporation Limited (P) minus 2.5% p.a. (P-2.5%), and thereafter at (P), subject to fluctuation. The final interest rate will be determined by the Designated Financing Company from time to time at its absolute discretion.

Such decision is independent from the Vendor and the Vendor shall under no circumstances be responsible therefor. Irrespective of whether any loan is granted or not, the Purchaser shall complete the sale and purchase in accordance with the agreement of sale and purchase and pay the full Purchase Price.

The Purchaser agrees not to raise any objection or requisition to any of the aforesaid.

Notwithstanding Clause (1) above, the Vendor shall have the right (but not the obligation) (whether before or after completion) to substitute and/or adjust the Chattels, or any of them, with finishes, fittings, partitions, furniture, decorative features, appliances or chattels of similar or comparable quality, quantity, ambience, design, style, size, finishes and/or colour without further notice to the Purchaser, and the Purchaser agrees not to raise any objection or requisition to any of the aforesaid.
